<u>Carer Concessionary Ticket T&Cs</u>

- 1. One registered carer may attend the RAF Cosford Air Show 2024 for free with a paying adult. One registered carer concessionary ticket may be allocated per disabled guest. Carers must have a Standard Adult Ticket to gain entry to the event.
- 2. A child (or children) aged 15 and under with a disability must be accompanied by a paying adult.
- 3. For information regarding Hospitality Enclosures, please contact the Air Show Office by telephone 01902 377922 (Mon-Fri 10.00am-4.00pm)
- 4. Tickets should not be bought prior to the Carer Concessionary ticket application being approved as the Carers Concessionary discount cannot be applied retrospectively.
- 5. The Carer Concessionary Ticket is issued in the form of a code that discounts the full price of one Standard Adult Ticket. The purchase of tickets is facilitated by SEE Tickets and is subject to booking fees. The code issued to obtain the complimentary carer's ticket shall is strictly one time use only, will not be reissued and must not be distributed or shared.
- 6. The RAF Cosford Air Show reserves the right to check a person's eligibility under the Equality Act 2010.
- 7. Evidence is accepted as a copy in the following format: JPEG, PNG, PDF. Hard copies of evidence will not be returned to applicants. For this reason, original documents must not be submitted.
- 8. The Carer's Concessionary Ticket is non transferable, non-refundable and not for resale.
- 9. The Carer's Concessionary Ticket remains the property of the RAF Cosford Air Show Office.
- 10. The final decision to approve and decline applications for the Carer's Concessionary Ticket remains solely with the RAF Cosford Air Show Office, reserving the right to decline any application for the carer's concessionary ticket.
- 11. The registered carer and disabled visitor must arrive at the Air Show in the same vehicle. Those with limited mobility may have difficulty accessing RAF Cosford by public transport, therefore it is strongly recommended that the registered carer and disabled guest drive to the event in their own vehicle.
- 12. In order for the application to be considered, the application must meet the following criteria:
 - The following completed documents must be submitted simultaneously within one calendar month of the initial telephone conversation with the RAF Cosford Air Show Office:
 - i. AS24 Carer Concessionary Ticket Application Form
 - ii. TWO or more copies of the following evidence:
 - Confirmation of Disability Living Allowance (DLA). DLA must be at the most recent higher rate higher rate for care and middle rate for mobility.
 - Confirmation of Receipt of Personal Independence Payments (PIP)
 of Daily Living Component at the Enhanced Level for Care and or
 Mobility. Either in the form of a letter stating that the benefit has
 been awarded, or the actual Allowance book.
 - 3. Certification of being registered blind, partially sighted or deaf
 - 4. Access Card showing the +1 or equivalent 'carer required' symbol
 - 5. Valid Blue Badge
 - b. Answers to the AS24 Carer Concessionary Ticket Application Form must indicate that the Registered Carer has caring responsibilities to the named disabled guest.

- 13. The registered carer and corresponding individual in need of assistance attending the RAF Cosford Air Show must be named on the Application Form.
- 14. The Carer Concessionary ticket must be requested over the telephone
- 15. The completed application form and evidence must be received at the RAF Cosford Air Show Office within one calendar month of the initial telephone call to the RAF Cosford Air Show Office and before the deadline of Monday 13th May 2024 or prior to tickets selling out. The Carer Concessionary Ticket will cease to be available to purchase at the point that tickets to the RAF Cosford Air Show 2024 sell out.
- 16. The RAF Cosford Air Show are unable to process late applications.
- 17. The RAF Cosford Air Show cannot accept applications on arrival at the event.
- 18. The RAF Cosford Air Show Office reserve the right to amend or withdraw the Carer Concessionary Ticket and Terms & Conditions of purchase with no notice.
